Importers handling LCL/FCL ocean freight who need pallet receiving, palletization, and dispatch from a South Florida port-adjacent facility.

B2B sellers consolidating cargo for retail distribution centers.

CORE SERVICE LINES

Inbound & receiving — pallet, container, and small-parcel receiving with photo-documented receiving reports.

Storage & inventory — pallet, oversized, bin, and shelf storage; monthly inventory statements and cycle counts.

Labeling & compliance — FNSKU, retail, and custom labels; suffocation, expiration, and country-of-origin marks.

Prep, pack & kitting — poly bagging, bundling, multi-pack assembly, sortation.

Outbound & dispatch — palletizing, cargo consolidation, weekly Amazon FBA inbound, daily DTC parcels.

Reverse logistics — returns inspection, re-prep, restock, or write-off.

WHY SUNPORT

Published rate card. Our à la carte Schedule A is on the Services page — <https://sunport-prep.com/services>. No bespoke pricing, no surprise line items.

One signed agreement. Receiving, storage, prep, fulfillment, eco packaging, inventory management, and labor all covered under one Warehouse Services Agreement.

South Florida geometry. Minutes from Port Everglades, Port of Miami, MIA, and FLL — the right launchpad for East Coast inbound and outbound.

Direct lines. A small, hands-on team. You talk to the people running the floor, not a support queue.

COMMERCIAL TERMS

Month-to-month engagement. No long-term commitment, no setup fees for standard onboarding.

Minimum monthly service fee \$500–\$1,000 depending on volume.

Storage billed monthly in advance; fulfillment and handling monthly in arrears. Net 30 from invoice date.

Carrier charges (UPS, FedEx, USPS, LTL) billed separately at cost.
